Furthermore, to continue to inspire our junior members we would like the Ko Dan Ja members to think about possible demonstrations to present to the Region on Saturday morning before the competition begins (April 14th). We would like you to submit your demonstration ideas to us by March 31st for review. We hope that as the leadership of our Region that you will set a good example for our junior members and participate in the Ko Dan Ja events.

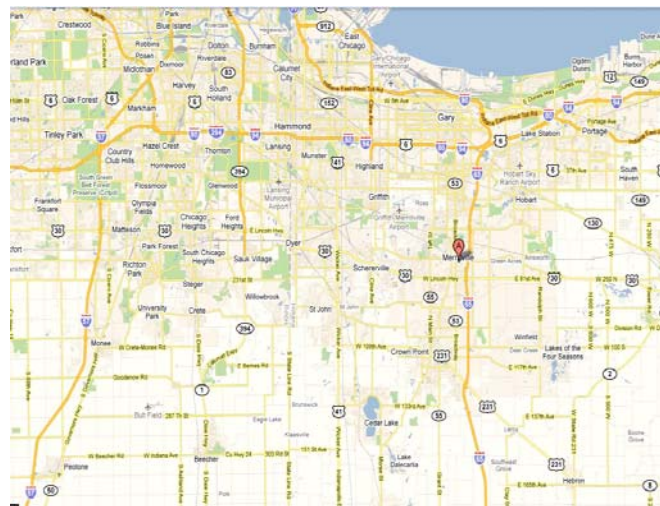
